# 11:15 AM ET Strategic Prioritization of Settlement Dollars and Clarification on Existing Financial Support Mechanisms

Session Objectives: The current SUD treatment and recovery system is insufficiently built-up and supported by a patchwork of payer reimbursement, philanthropic entities, and state/federal directed revenue streams. Settlement dollars represent a unique opportunity to address gaps and silos in the built system, creating access to new resources for individuals in need to treatment and recovery resources. However, many communities are not receiving sufficient funds to marginally improve access through settlement dollars alone and, even those that are, must ensure compliance with their memorandum of understanding and guiding legislation (if in place). This session will:

- Explore optimal investment strategies and clarify existing funding streams for communities in order to avoid duplication and maximize the total financial support available to them.
- Identify existing tools, resources, and models that can support states, counties and localities in their understanding of how opioid settlement funds can be leveraged to support and wrap-around (e.g., via blending and braiding) existing federal and state funding sources for SUD prevention, treatment and recovery services.

# **Discussion Questions:**

- What investments are highest priorities for local, county, and state policymakers and which funding streams are best aligned to support besides settlement dollars?
- What obstacles are preventing communities from currently using existing funding streams, such as those from HRSA, AHRQ, SAMHSA, the CDC, etc.? Are there opportunities to reduce these burdens and challenges?
- How can there be accountability for settlement dollar outcomes without introducing significant burden?

# 11:45 AM ET Sustainability of Opioid Settlement Funds Spending: Leveraging Value-based Payment Models

**Session Objectives:** While settlement dollars and current financial supports, when appropriately blended and braided, can help improve systems of care, much of these funds are time-limited and are not predictable. Existing and new systems of care need sustainable financing and reimbursement and value-based payments may offer an opportunity to support these improvements in the long-term. This session will:



- Identify existing gaps and opportunities for leveraging opioid settlement funds in support of value-based payment readiness (e.g., workforce, physical and data infrastructure, data collection, coordination)
- Discuss the role of opioid settlement funds in extending and enhancing existing value-based payment model efforts, including those addressing the needs of individuals with behavioral health needs.

#### **Discussion Questions:**

- Are there existing behavioral health/SUD payment models that can serve as a
  use-case for other payers and communities to work from? Where can opioid
  settlement funds be used to increase VBP readiness within those models?
- What payment mechanisms could potentially be used to drive integration of providers and payers to support newly created systems of care?
- How can Accountable Care Organizations and Community-based organizations that primarily exist in the physical health space be used to support recoveryoriented systems of care in the long-term?
