Mark McClellan, MD, PhD
Director, Duke-Margolis Institute for Health Policy

Mark McClellan, MD, PhD, is Director and Robert J. Margolis, M.D., Professor of Business, Medicine and Policy at the Duke-Margolis Institute for Health Policy at Duke University. He is a physician-economist who focuses on quality and value in health care, including payment reform, real-world evidence and more effective drug and device innovation. At the center of the nation's efforts to combat the COVID-19 pandemic, the author of COVID-19 response roadmap, and co-author of a comprehensive set health policy strategies for COVID vaccines, testing, and treatments, Dr. McClellan and his Duke-Margolis colleagues are now focused on health policy strategies and solutions to advance the resilience and interconnectedness of 21st Century public health and health care. Mark is a former administrator of the Centers for Medicare & Medicaid Services and former commissioner of the U.S. Food and Drug Administration, where he developed and implemented major reforms in health policy. Dr. McClellan is an independent board member on the boards of Johnson & Johnson, Cigna, Alignment Healthcare, and Prognom IQ; co-chairs the Guiding Committee for the Health Care Payment Learning and Action Network; and serves as an advisor for Arsenal Capital Group, Blackstone Life Sciences.





### Congressional Action to Support Accelerating Accountable Care: Where We've Been and Where We're Going

After spending nearly three decades practicing medicine in North Texas, Congressman Burgess has served the constituents of the 26th District since 2003 in the United States House of Representatives. He currently serves on the House Rules Committee, House Energy and Commerce Committee, and the House Budget Committee. Congressman Burgess has served on the Rules Committee since 2013 and was appointed as Chairman in 2024. In addition, he chairs the Health Care Task Force on the Budget Committee and serves on the Health, Energy, and Oversight and Investigations subcommittees of Energy and Commerce.

As of the 118th Congress, he is the most senior medical doctor on both sides of the aisle serving in the House of Representatives. Because of his medical background, Congressman Burgess has been a strong advocate for health care legislation aimed at reducing health care costs, improving choices, reforming liability laws to put the needs of patients first, and ensuring there are enough doctors in the public and private sector to care for America's patients and veterans. He received his M.D. from the University of Texas Medical School in Houston and completed his residency programs at Parkland Hospital in Dallas. He also received a master's degree in Medical Management from the University of Texas at Dallas, and in May 2009 was awarded an honorary Doctorate of Public Service from the University of North Texas Health Sciences Center.





### The Next Iteration of MACRA: Building on MIPS and AAPMs to Improve Medicare's Payment Systems

Susan Dentzer is President and Chief Executive Officer of America's Physician Groups, the nonprofit organization representing more than 360 large physician groups focused on patient-centered, coordinated, and integrated health care that is accountable for both costs and quality. Dentzer is a highly respected health and health policy thought leader, a frequent speaker and commentator, and an author of commentaries in Modern Healthcare, the New England Journal of Medicine Catalyst, the American Journal of Public Health, and other prominent publications. She is also the editor and lead author of the book Health Care Without Walls: A Roadmap for Reinventing U.S. Health Care. She is an elected member of the National Academy of Medicine and the Council on Foreign Relations and is a fellow of the National Academy of Social Insurance and the Hastings Center. Dentzer graduated from Dartmouth and also holds a master's degree in health care delivery science from the institution.

Dentzer serves on the advisory boards of the Robert J. Margolis Institute for Health Policy at Duke University; the Center for Global Health Equity at Dartmouth; and the Philip R. Lee Institute for Health Policy Studies at the University of California – San Francisco (UCSF). From March 2021-March 2023, Dentzer chaired the Board of Directors of Research!America, which advocates for health-related research, and formerly chaired the board of the Global Health Council. Dentzer was also a longtime member of the Board of Directors of the International Rescue Committee, the organization that works in more than 40 countries to help those affected by humanitarian crises survive and rebuild their lives, and currently serves on IRC's Board of Advisors.







Michael McWilliams, MD, PhD Warren Alpert Foundation Professor of Health Care Policy, Professor of Medicine, Department of Health Care Policy, Harvard Medical School

J. Michael McWilliams, MD, PhD is the Warren Alpert Foundation Professor of Health Care Policy and Professor of Medicine at Harvard Medical School and a physician at Brigham and Women's Hospital. In his research, Dr. McWilliams is examining a range of topics, including Medicare Advantage, the design of population-based payment models, risk adjustment, market consolidation, and strategies for leveraging professionalism more productively in health care. He is an elected member of the National Academy of Medicine and American Society for Clinical Investigation. In other roles, Dr. McWilliams serves as a Senior Advisor to the Center for Medicare & Medicaid Innovation, member of the board of directors for the Institute for Accountable Care, and member of the editorial boards for Health Services Research and the American Journal of Managed Care. Previously, he served as an Associate Editor for JAMA Internal Medicine and Comments Editor for the Journal of General Internal Medicine. Dr. McWilliams received his BS with highest distinction in biology as a Morehead Scholar from the University of North Carolina at Chapel Hill, his MD magna cum laude from Harvard Medical School, and his PhD in Health Policy from Harvard University. He completed his residency in general internal medicine at Brigham and Women's Hospital.

#### Advancing Alternative Payment Models: Accelerating Adoption of Accountable Care in the Near-Term

Dr. Saunders is Senior Research Director, Health Care Transformation at Duke-Margolis. In this role, he oversees work on payment and delivery reform initiatives, including generating practical evidence; translating that evidence into solutions; and accelerating progress on policy actions at the state, national, and international levels. The team's work focuses on Medicare accountable care transformations, health care transformation for health equity and social needs, Medicaid and state transformation in North Carolina and other states, medically and socially underserved populations, and bolstering population health. Prior to joining Duke-Margolis, Dr. Saunders was a Senior Director and then Senior Advisor to the President of the National Quality Forum, Senior Program Officer at the Institute of Medicine, and managed health care legislative affairs for Representative Rush D. His work encompasses applying and studying systems improvement methods across a broad range of areas, including primary and sub-specialty care, communities, and public health settings, to improve the health outcomes of children, families, and communities. He served as Co-Director of the Center from 2016-2024 and currently leads the Center's efforts focused on advancing the science of networked Learning Health Systems. Over the last 20 years, he and his research team have developed innovative approaches that engage patients, their families, clinicians, scientists, and communities in developing network-based learning health systems that improve care, spawn innovation, and accelerate research. Dr. Margolis was co-PI of an NIH Transformative Research Grant focused on developing learning health systems for children with chronic illness by harnessing all stakeholders' inherent motivation and expertise. Dr. Margolis has extensive experience in large-scale comparative effectiveness research, creating large-scale interoperable data systems, managing large project teams, and engaging individuals from diverse backgrounds to coproduce improved care and research. He served as Chair of the PCORnet Council, guiding PCORI's investment in transforming research infrastructure in the US. The ImproveCareNow Network, which he leads, was awarded the Drucker Prize, the largest non-profit management and innovation award in the US.
